

Energy Saving Trust Complaints and Feedback Procedure

Energy Saving Trust is committed to providing the highest possible service.

We value complaints and use information from them to help us improve our services.

If something goes wrong or you are dissatisfied with our services, please tell us. This document describes our complaints procedure and how to make a complaint. It also tells you about our standards and what you can expect from us.

How do I complain?

1. If you have a specific complaint about a loan or grant you have applied for through the Energy Saving Trust

When complaining, tell us:

- your full name and address
- as much as you can about the complaint
- what has gone wrong, and
- how you want us to resolve the matter.

1.1 How long do I have to make a complaint?

Normally, you must make your complaint within six months of:

- the event you want to complain about, or
- finding out that you have a reason to complain, but no longer than 12 months after the event itself.

In exceptional circumstances, we may be able to accept a complaint after the time limit. If you feel that the time limit should not apply to your complaint, please tell us why.

1.2 What happens when I have complained?

We will always tell you who is dealing with your complaint.

We aim to resolve complaints quickly and close to where we provided the service. This could mean an on-the-spot apology and explanation if something has clearly gone wrong and immediate action to resolve the problem.

We will address complaints as quickly as possible and will:

- aim to acknowledge receipt of your complaint and if possible respond within two working days
- discuss your complaint with you to understand why you are dissatisfied and what outcome you are looking for
- give you a full response to the complaint as soon as possible and within five working days.

If our investigation will take longer than five working days, we will tell you. We will notify you of the revised time frame with you and keep you updated on progress.

1.3 How will I be notified of the outcome of my complaint?

Once your complaint has been fully investigated, we will issue a Final Response Letter that explains our conclusive position.

1.4 How do I take my complaint further?

You have the right to take your complaint to the Financial Ombudsman Service (FOS).
