Sustainable travel review

Whilst many employees are not currently commuting to offices or travelling for business due to COVID-19 restrictions, taking the time to review your staff travel policies and initiatives now can be a good investment. Some employees may be more open-minded about changing their habits and shifting to more sustainable modes when they return, and some aspects of older policies may no longer make sense.

Activity in this area also signals your commitment to improving air quality and addressing the climate emergency. It's an opportunity to lead by example while improving staff health and wellbeing.

Last mile deliveries and ecargo bikes


