What is a low emission zone?

A low emission zone aims to improve air quality by restricting highly polluting road vehicles from entering a set area.

The Scottish Government is planning to introduce low emission zones in Scotland's four largest cities: Aberdeen, Dundee, Edinburgh and Glasgow.

Low emission zones set criteria based on vehicle Euro emission standards. In the future, vehicles that do not meet the minimum standard will face a penalty if they enter low emission zones.

Vehicles that will be free to enter the zones without incurring a penalty are:

	Fuel and category	Minimum standard
	Petrol – All types	Euro 4/IV
	Diesel – All types	Euro 6/VI
	Motorcycles	Euro 3
	Electric vehicles	Most plug-in vehicles*

Why take action?

- The NHS considers air pollution to be the biggest environmental threat to health in the UK.
- 43% of deaths from chronic obstructive pulmonary disease and 29% of lung cancer cases are a result of air pollution.
- Improving air quality will not only enhance our health as a nation, it will also help combat climate change.

*Plug-in vehicles include plug-in hybrid electric vehicles (PHEVs), extended-range electric vehicles (E-REVs) and battery electric vehicles (BEVs). Non plug-in or mild hybrids are considered under the petrol or diesel category.



How does it impact my business?

Any Euro 3 or earlier petrol vehicle or Euro 5 or earlier diesel vehicle entering the zones will receive penalties.

Once the zones come into effect, businesses will need to consider the impact of daily charges if vehicles do not comply with the standards.

By moving away from older and more polluting vehicles, your business can save money whilst directly contributing to improving local air quality and reducing emissions.

What support is available?

Energy Saving Trust is offering micro businesses and sole traders, with an operating site within 20km of the low emission zones, a £2,500 grant towards the safe disposal of vehicles that do not meet the zone standards.

The vehicle must be disposed at an authorised treatment facility.

Is my business eligible?

To be eligible, you must meet all of the following criteria:

- 01** Have an operating site within 20km of the planned zones in Aberdeen, Dundee, Edinburgh or Glasgow.
- 02** Own a Euro 3 or earlier petrol vehicle or a Euro 5 or earlier diesel vehicle.
- 03** Meet the definition of a micro business by having:
 - Nine or fewer full-time equivalent employees.
 - A turnover of £632,000 or less or £316,000 or less on its balance sheet.
