

## Mobility and Scrappage Fund

## Eligibility criteria for households

To qualify for funding, you must meet all of the below criteria:



1. You must live within a targeted area as selected by Transport Scotland. You can find a table of eligible postcodes in page 3 of this document.



- 2. You must own an eligible older vehicle which falls under the following emission standards:
  - Euro 3 or older petrol vehicles this generally applies to vehicles registered before 2006
  - Euro 5 or older diesel vehicles this **generally applies** to vehicles registered before September 2015

The vehicle must be fully operational and roadworthy at time of application, this includes holding a current MOT, being fully taxed and insured. Vehicles without a valid MOT or road tax or those that have been SORN are not eligible for funding.

3. You must have owned and be the named registered keeper of the vehicle for a period of at least 12 months prior to applying to this fund. You must be the outright owner of the vehicle; Energy Saving Trust is not liable for any outstanding finance.






4. You must be in receipt of benefits. This fund has been set up to support households falling under particular income criteria and therefore, you will need to declare your household income at application stage.

Evidence of benefit receipt in the name of the applicant is required as evidence of eligibility.

5. You and your household must not have previously received funding from the Mobility and Scrappage Fund or the Low Emission Zone Support Fund for Households.
