ORCS claims guidance

You will need to provide the following documents to submit the ORCS claim:

- Grant claim form
- Monitoring Log (a separate tab on the grant claim form spreadsheet)
- Invoices with a detailed breakdown of costs
- National Chargepoint Registry (NCR) log (showing all chargepoints for the project)

Invoices

If an invoice includes more than one 'Type of Cost', individual costs must be itemised.

Example invoice B

As you can see in the examples above, the DNO invoice (A) is for one type of cost. However, the second invoice (B) includes multiple types of costs (hardware, installation etc.), which must be itemised.

Grant claim form

Each invoice must be broken down into 'Type of Cost' on Section D of the grant claim form. The 'Type of Cost' section includes: Chargepoint hardware, labour and installation, electrical connection costs, signs and lines, surveys and other.

If an invoice has multiple lines of costs for one 'Type of Cost', as invoice B has for 'Chargepoint hardware' and 'Labour and installation', these figures can be combined into one row on the grant claim form, as follows:

Monitoring log

One row of the monitoring log should be completed for each chargepoint (not socket). It is important that the Chargepoint ID on NCR and Postcode fields match the corresponding data on the NCR log.

NCR log

Chargepoint device owners or controllers can register publicly accessible chargepoints on the National Chargepoint Registry at <u>NCR - National Chargepoint Registry (dft.gov.uk)</u>.

Once all chargepoints have been registered, a copy of the NCR log can be downloaded here, using the username and password set up during the registration process:
